PRESIDENT's REPORT

For the year ended 31st March 2019


I have a great pleasure is presenting our 22nd Annual Report for the year ending 31st March 2019 before this General Body Meeting. Last year, Annual General Body Meeting was held on 23rd September 2018, at VISCOM Department, Loyola College Campus, Chennai during Karam festival celebration.

Initiative and achievements:

- ❖ During the year 2018-19, total 6 Executive Committee Meetings were conducted at various places i.e. Annanur, Ayanavaram, ICF South Colony and Villivakkam to discuss the various activities.
- ❖ To encourage the talented students of our association, we have started in the year 2007 to give cash awards to the 10th and 12th passed students with good marks. In continuation with this Shri Vijay Kumar Toppo and family has come forward and started to sponsor the cash award and appreciation certificate in the memory of their daughter Captain Permilla V. Toppo from the year 2008 onward and 116 students have been awarded till 2018.
- ❖ Membership strength of our association started with 21 numbers in 1997 and today it is about 490 in number of which 89 members have enrolled themselves as a life member. This is a pride moment for us as it shows their commitment for the better functioning and support to the association.
- ❖ Apart from Chennai area, our people from various part of Tamil Nadu i.e. Jolarpettai, Erode and Coimbatore have also been enrolled. We welcome many more members to enroll as life member for strengthening our association, which is involved in understanding and preservations of our rich tribal culture, unity and identity.
- ❖ A Branch Office was opened in the year 2009 at Jolarpettai considering their number of enrollment and interest shown by them as well as its geographical location to cater the need of these areas. About 150 members of the Jolarpoettai branch are successfully arranging and celebrating cultural festival and other activities regularly at Jolarpettai.

- ❖ Last year KaramParab, Christmas gathering, Picnic and SarhulParab were celebrated during the month of September, December, January and March respectively. 19th-20th October 2018 13th National Kurukh Conference was hosted by Association at Loyola College Campus Chennai.
- ❖ Football tournament for the members of the association was started in year 2009 at Loyola College football ground. From the year 2012-13, a rolling trophy has been started in the year 2015, tournament was organized during the month of February 2019 at Loyola College ground in which 14 teams played. In spite of busy metro life, successful organization of such events shows our brotherhood among us and such activities will strengthen it further.
- ❖ With the help of Shri VIRENDRA KERKETTA Income Tax Dept. Chennai, Every year Our Association account Auditing is been done regularly through him and also he has helped us in obtaining **Permanent Account Number (PAN)** card in the name of Association. Number is **AAEAC2687E**.
- ❖ New office bearers for authorized signatory of Association Bank account are as following President - Shri PramodBhagat, Treasurer - Shri MunnaLohar, Assistant Secretary Shri BisikesanEkka for future transactions.
- ❖ The statements of Receipts & Payments and Income & Expenditure has been displayed in the Notice Board (Cash balance: around Rs.2,83,679/- with valuable assets). Copy of the same is available and can be obtained from the registration counter. I hope that you would go through the same and with your permission, I am moving it for adoption by the General Body.
- ❖ Apart from membership fees, monthly subscription fee have also been collected from members and have been utilized properly for expense of the Association activities.
- ❖ I thank and appreciate to all the committee members who in spite of their busy life could able to render their valuable time and service for improvements and strengthening the activities of our Association. I would like to acknowledge Treasurer Shri MunnaLohar (Southern Railway, Chennai) and Assistant Treasurer Shri EliazarBaxla (Southern Railway, Chennai) for their proper maintenance of books and accounts and also timely submission of accounts for auditing. I hope that the same zeal and enthusiasm will continued in future also.

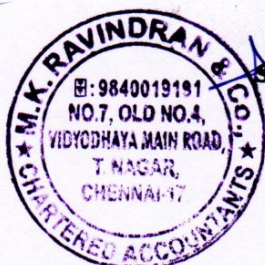

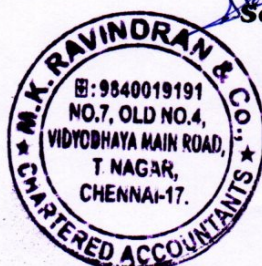


